

# 2023 The 8th International Conference on Ocean Law & Policy

## Call for papers:

### Topic : AI Impact on International Maritime Law

#### Description of the Topic:

These years, the issue of artificial intelligence (AI) has been widely discussed world-wide. In the field of Marine Artificial Intelligence application, AI exerts its influence on marine areas such as scientific research, resource exploration, the safety of navigation, sea area monitoring and law enforcement, environmental protection, and climate change prediction. Law has been recognized as one of the most vital behavioral norms. Due to AI's ability to learn, analyze, and cognize exceeding humans, in the area of conventions on carriage of goods by sea, maritime laws, and Marine Insurance laws, the international maritime conventions enacted by Committee Maritime international, United Nations Commission on International Trade Law, United Nations Conference on Trade and Development, International Maritime Organization, European Council, and Hague Conference on Private International Law may raise many problems. Specifically, the fatalities and property damage caused by maritime accidents, illegal fishing, discharge of pollutants, and smuggling conducted by autonomous ships. Therefore, apart from universal issues of ethics and intellectual property, the standard for identifying the actors, and the attribution of civil, criminal, and administrative responsibilities will also be influenced by human factors when AI is replaced by AI to take over human behavior, leading to the inapplicability of the current legal logic on traditional maritime law framework. The conference aims to delve into the legal issues on above international conventions arising from the AI application in the marine field, expecting to collect perspectives and inspire suitable solutions.
